

Privacy policy

We are serious about protecting your data and your privacy. We collect, use, and store your personal data strictly in accordance with the applicable data protection laws. Please read the following information to ensure that you are fully informed about how we collect, process, and use personal data on our website.

1 Contact information

Your data will be processed in the name and on behalf of the Manekino Cultural Association, the initiator of the project *You Are Another Me – A Cathedral of the Body*.

2 Data collection for system-internal and statistical purposes

Your browser automatically transmits data to our web server for technical reasons when you access our website (such as the date and time you accessed the platform, the URL of the referring website, the browser type and version, the operating system, the sections you visited on the platform, etc.). This data is stored separately from any other information you enter when using our website, and it does not make or contain reference to your identity as a person.

3 Personal data collection and processing

Personal data is collected and processed any time you decide to provide it to us on our website. This occurs when subscribing to our newsletter, which will keep you informed about topics relevant to the Romanian Participation at La Biennale di Venezia 2022. The only mandatory information for sending the newsletter is your email address, which we store after your registration.

You can withdraw your consent to receive the newsletter at any time by unsubscribing. You can declare the withdrawal simply by calling up the link provided in every newsletter email.

In the case of a withdrawal of the newsletter mailing, we will exclude you from future newsletter mailings. The processing operations prior to your withdrawal remain unaffected by this. Your data will not be used by us for automated decision-making or profiling.

4 Data transmission

Any data you provide when using our forms is always transferred encrypted. In case external service providers come into contact with personal data, we enforce mandatory legal, technical and organizational measures to guarantee compliance with data protection regulations.

5 Links to other websites

Our website might contain links to other websites. We have no influence on the compliance of operators of other websites with data protection regulations.

We are responsible for our own content according to general law. Our content is not to be mistaken with linked content of other providers. We assume no responsibility for third-party content, which is provided via links for use, and do not adopt their content as our own.

Liability for illegal, inaccurate or incomplete content and, in particular, for damages resulting from the use or non-use of such information is the sole responsibility of the provider of the site to which links are provided.

6 Your rights to your personal data

According to the General Data Protection Regulation, you have the right to obtain information about your stored personal data free of charge and, if necessary, the right to correct, restrict or delete such data at any time. To the extent we are required to comply with legal storage obligations, we shall block your data from further processing so that your data can no longer be used for the purposes mentioned above.

You also have the right to request that we send you in electronic form any of your personal data stored by us. You may withdraw your consent that your data be stored or processed at any time. Should you choose to exercise this right, we will immediately delete your data that we have stored and block processing of any data that cannot be deleted due to legal requirements.

7 Right to object on a case-by-case basis

You have the right to object at any time, on grounds relating to your particular situation, to the processing of personal data concerning you.

If you object, we will no longer process your personal data unless we can demonstrate compelling legitimate grounds for the processing, which override your interests, rights and freedom, or the processing serves the purpose of asserting, exercising or defending legal claims.

8 Data security

Your personal data is transmitted online in encrypted form. We use SSL (Secure Sockets Layer) encryption technology. Please note that online data transmission (e.g. even when communicating via email) may exhibit security gaps. It is not possible to guarantee full protection against access by third parties.

We use technical and organizational security measures to secure our website and other systems, keeping your data safe from loss, destruction, access, modification or processing by unauthorized parties. We continually update these security measures in line with the latest technology.
